

DELAY IN DESPATCH OF THE CIRCULAR RELATING TO CONNECTED TRANSACTION: PROPOSED ISSUE OF CONVERTIBLE NOTES



SUMMARY

As the Company requires additional time to prepare and finalise certain information to be included in the Circular, it is now expected that the despatch date of the Circular will be postponed to not later than 28 June 2019 and the EGM will be held in mid to late July 2019.



The directors (the “**Directors**” or the “**Board**”) of Regent Pacific Group Limited (the “**Company**”) refer to the announcement issued by the Company on 29 May 2019 (the “**Announcement**”) in respect of the proposed issue of Convertible Notes, which constitutes a connected transaction of the Company under Chapter 14A of the HK Listing Rules.



Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meaning given to them in the Announcement.

As stated in the Announcement, the circular (the “**Circular**”) containing, among other things, further details of the Subscription Agreements and the Convertible Notes, the proposed increase in the authorised share capital of the Company and notice of the EGM, will be despatched to the Shareholders as soon as reasonably practicable and on or before 21 June 2019.
