## SUMMARY

As the Company requires additional time to prepare and finalise certain information to be included in the Circular, it is now expected that the despatch date of the Circular will be further postponed to not later than 5 July 2019 and the EGM will be held in late July 2019.

The directors (the "Directors" or the "Board") of Regent Pacific Group Limited (the "Company") refer to the announcement issued by the Company on 29 May 2019 in respect of the proposed issue of Convertible Notes, which constitutes a connected transaction of the Company under Chapter 14A of the HK Listing Rules and subsequently the announcement issued on 21 June 2019 in respect of the delay in the despatch of the Circular (collectively, the "Announcements").



As stated in the Announcements, the Circular containing, among other things, further details of the Subscription Agreements and the Convertible Notes, the proposed increase in the authorised share capital of the Company and notice of the EGM, as postponed, will be despatched to the Shareholders no later than 28 June 2019.
